Welcome to Q2 2025! I think it's safe to say that winter is behind us, and we're likely all looking forward to a solid paving and construction season! I'm sure many of you have heard the saying that Colorado has two seasons: Winter and Construction. If you're like me, there's nothing in the world that gives me more energy than putting on a hard hat, vest, and boots and walking through an active construction site. Maybe it's because I grew up in a construction family and worked as a laborer every summer as I was going to college. There's nothing more satisfying than looking back at the end of a hard day or week and seeing all the progress that you made.

FIRST RESPONDER

ROAD AND BRIDGE CREW SPRING INTO ACTION TO HELP SAVE TODDLER

An Arapahoe County Road and Bridge crew recently went above their call of duty to help a mother with her two-year-old daughter, who was choking.

The West Patching crew was working on a cul-de-sac on South Biscay Court within the Siena community, when Road Maintenance Technician Ryan Ehlert noticed the woman in distress as she came out of her home.

"I happened to look up and saw a woman place a baby on the driveway," Ehlert said. "The situation just didn't look right. I could tell she needed help, so I dropped what I was doing and ran over."

Ehlert said he placed his hand under the girl's head as her mother used a plastic bulb syringe to suction her airway. As Ehlert assisted the woman, Road Maintenance Inspector Scott Goude called 911.

After a few tense moments, Ehlert said he could tell the girl was breathing and the father of two young girls said his paternal instincts kicked in. "I told the mother that she was breathing, and I picked the baby up," he said. "I then reassured the baby that everything was going to be OK."

As Ehlert was comforting the girl, the woman placed a call to her husband. Within minutes an Arapahoe County Sheriff deputy was on scene, followed by an ambulance crew.

"Once they arrived, I handed over the baby and got out of the way," Ehlert said.

Road and Bridge Operations Manager Michael Haraldson said he is proud of the crew's willingness to help.

"What Ryan did was amazing," Haraldson said. "The entire crew deserves credit. Scott called 911, and we had trucks and equipment parked in the roadway. These were moved quickly so when EMS arrived, they had clear access."

Ehlert joined the County on December 30, 2024.

"I have daughters, and I wanted to do what I could to help," said Ehlert, whose daughters are two and five.

Patching Supervisor Justin Pauley said the couple was very thankful for the crew's help as they took their daughter to the hospital to be checked. The following day, the grateful parents came outside as the crew was continuing to do their work to let them know their daughter was going to be fine and an X-ray of her stomach showed she had swallowed a ring. The full circle moment was during this day, the crew looked over and the little girl was running around the front yard with her dad. This was incredibly special to the entire crew.

"This really hit home for us, as many of us have kids and Ryan has a daughter the same age," Pauley said. "I'm thankful everyone is OK."
